Contract Agreement

PLEASE READ ALL OF THIS CONTRACT BEFORE INITIALING EACH SECTION

Buyer agrees they are able to provide proper care for the above listed puppy, be a responsible owner and can have the puppy in their home (ex. landlord approved, no allergies of anyone in the home, prepared for the energy level of a puppy, ect.) before signing this contract. **WE DO NOT OFFER REFUNDS.** A 45% REFUND OF THE PUPPY'S FEE MAY BE OFFERED AT THE BREEDERS DISCRETION WITHIN 30 DAYS OF THE DATE ACQUIRED IF THE PUPPY IS FREE OF ILLNESS OR INJURY. THE PUPPY WILL BE SUBJECTED TO EVALUATION BY THE BREEDER AND/OR THEIR VETERINARIAN PRIOR TO REFUND APPROVAL. TRANSPORTATION TO THE BREEDER IS BUYERS RESPONSIBILITY. PUPPY CAN BE RETURNED TO THE BREEDER AT ANY TIME DURING ITS LIFETIME PROVIDED IT POSES NO RISK TO HUMANS OR CANINES SUCH AS BUT NOT LIMITED TO ILLNESS, AGGRESSION, ETC. NO REFUND WILL BE GIVEN! If the puppy is sold/ re-homed at any time this contract becomes null and void. No exceptions. ***Buyer Initials:** _____

I, the breeder, do my own health examinations and worming of all puppies born in our program. I am by no means a certified veterinarian, but I am knowledgeable on canine health care and temperament. All puppies receive multiple health examinations by me, the breeder, during their time with us, in addition to a thorough health examination, by me, the breeder, the day of placement to ensure the puppy is in good health prior to placement. If placement is conducted, the above listed puppy was found to be healthy and in good physical health at the time of placement with the buyer. The new owner (buyer) is responsible for taking the above listed puppy to a licensed veterinarian within 72 (seventy two) hours or 3 (three) business days from the date this contract is signed for a certified veterinarian examination. This contract will become null and void if not followed accordingly.

I, the breeder of this puppy, guarantee that the puppy is healthy and free of all diseases, injuries, and temperament concerns to the best of my knowledge. Once the puppy leaves my premises and is no longer in my possession or care, then I the breeder of this puppy will no longer be responsible by any means physically or legally for the life, health, well being, actions, or behaviors of this puppy. I, the breeder, have personally checked this puppy out thoroughly to the best of my abilities and have found no visual faults with the above listed puppy; any faults will be duly noted on page 4 (four) of this contract. I, the breeder, WILL NOT BE HELD RESPONSIBLE FOR THIS PUPPY'S ACTIONS, BEHAVIORS, ILLNESSES, INJURIES, HEALTH CONDITIONS, ETC. ONCE IT LEAVES MY POSSESSION and I DO NOT pay or reimburse for ANY vet or legal bills/fines incurred after the puppy leaves my possession. NO CASH OR REFUNDS ARE GIVEN. ***Buyer Initials:** _____

The above listed puppy comes with a 1 year (365 day) health guarantee that starts from the date acquired. Should a licensed veterinarian find a **LIFE THREATENING GENETIC HEALTH ISSUE** with the above listed puppy, then a **REPLACEMENT** puppy from the next litter will be given. **NO CASH OR REFUND WILL BE GIVEN.** Physical results (test results paperwork) from a licensed veterinarian's findings of any life threatening genetic conditions must be sent to I,

the breeder ASAP by email. If the above listed puppy should die during the duration of this warranty and a genetic condition is the suspected cause, a necropsy must be performed at the buyer's expense and results sent to I, the breeder ASAP by email. If the necropsy results DOES NOT show the puppy in question, died from a LIFE THREATENING GENETIC defect then NO REPLACEMENT PUPPY WILL BE GIVEN. Necropsies can be performed by your local Agriculture Department for a low cost fee. This warranty DOES NOT cover illnesses, injuries, or any other non-life threatening genetic issues. The puppy MUST be taken to a licensed veterinarian within 72 (seventy two) hours or 3 (three) business days from the pickup date listed on this contract or this warranty will become NULL and VOID. NO EXCEPTIONS.

Puppy's first DHPP vaccine is administered by a licensed veterinarian between 7 and 8 weeks old please locate the date this vaccine was administered. Their second DHPP vaccination is due within 3-4 weeks from the listed date of their first DHPP vaccine on page 1 (one) of this contract. To keep your puppy healthy do not miss vaccinations! ALL WORMINGS ARE PERFORMED BY THE BREEDER AND NOT BY A VETERINARIAN. This puppy has already been wormed multiple times as stated on page 1 (one) in the medical record section of this contract. A signed copy of this contract will be provided to you at the time of pick up. It is YOUR RESPONSIBILITY as the new owner (buyer) to continue the above listed puppy's care. It is the new owners (buyers) responsibility to contact a licensed veterinarian of your choosing IMMEDIATELY if the puppy isn't eating, drinking properly, or having ANY type of issue(s) once the puppy leaves my possession and is in the new owners (buyers) possession. ***Buyer Initials:** _____

It is the responsibility of the buyer (new owner) to keep the above listed puppy's identification information up to date on their puppy's MICROCHIP and ID TAG on the puppy's collar. It is highly recommended that your puppy have an ID tag on their collar. Keeping this identification information up to date is IMPORTANT should your puppy get lost.

Buyer agrees that the above listed puppy WILL NOT be chained, left outside in extreme cold or hot weather, be outside without proper shelter and water, be without access to clean water, or neglected in any way and will receive routine veterinary care and vaccinations. It is the responsibility of the new owner (buyer) to ensure the safety of the puppy and that the puppy WILL NOT be left unsupervised around young children or allowed to be bothered or mistreated by anyone who comes in contact with the puppy for the remainder of its lifetime. ***Buyer Initials:** _____

All puppies are sold as PET COMPANIONS and PET QUALITY. Puppies ARE NOT GUARANTEED to be SHOW quality and are NOT PERMITTED TO BE BRED unless otherwise specified in this contract.

All puppies unless otherwise specified in this contract ARE to be SPAYED (females) or NEUTERED (males) at 24 (twenty four) months of age but not before 18 (eighteen) months of age to allow proper growth and health. NO BREEDING IS PERMITTED unless otherwise specified in this contract. All puppies are sold as companions only. It is the owners (buyers) responsibility to ensure the proper precautions are taken to prevent breeding. ***Buyer Initials:** _____

If for any reason this puppy does not work out with the new owner (buyer) or a situation arises that would displace this puppy, I, the breeder MUST be notified IMMEDIATELY upon the acknowledgement of said situation. This puppy is NOT

Your puppy needs to be started on a monthly heartworm preventative ASAP. Please speak with your veterinarian about starting monthly heartworm prevention.
